# HARBISON COMMUNITY ASSOCIATION MINUTES TO THE MEETING OF THE BOARD OF DIRECTORS April 30, 2019

The Harbison Community Association Board of Directors held a Regular Meeting on Tuesday, April 30, 2019 follow the Annual Meeting of the Members, which occurred on the same date - at 7:00pm. A quorum being present for the meeting, Mr. West called the meeting to order at 9:15pm.

Each elected Board Officer will serve one year - until the Board Elections in April, 2020.
